USPS Setup

Coosawattee River Resort along with the United States Postal Service has community mailboxes at five different locations within the resort. If you want to receive your mail at these boxes you must:

- 1) Register with the Gilmer County Sheriff's Office 911 Addressing Dept. located at the Gilmer County Courthouse. For questions, you can contact Gilmer Co. at 706-635-4652.
- 2) Take your completed 911 Address Verification to the Ellijay Post Office located at 801 Industrial Blvd. where you will be assigned a box number.
- 3) Bring your completed documentation from the Gilmer County Sheriff's Office 911 Addressing Dept. and the Post Office to Customer Service. If we have the keys to your mailbox, they will be given to you at no charge. If a lock change is necessary, there is a minimal administrative fee.

Electricity Setup

Power at your property is already on, but you will need to contact Georgia Power Company with your 911 street address to update the account with your contact and billing information. Internet/Cable Setup

Property Identification 911 Address Sign Application



Directions to Pool and Tennis Courts

The Recreation Center – 126 Mango Ln – 706-640-4028

The heated, enclosed pool is open for swimming year round 6:00AM-8:00PM. The game room, weight room, tennis court, basketball court, pickle ball, and 18-hole miniature golf course is open until 8:30PM. *Directions:* From the Eagle Mountain gate entrance off of Highway 382, turn right at the Coosawattee River Tubing Company and the barn onto Eagle Mountain Drive. Go to the three-way stop and turn left onto Mango Ln. Go around the curve and the Rec Center is on the right.

Riverside Pool - 545 Ogden Dr.

The Riverside Pool Center is a beautiful outdoor pool, largest in the resort, open from Memorial Day thru Labor Day

Tuesday - Saturday 8:00AM-8:00PM

Sunday & Monday 10:00AM-10:00PM

Directions: From Legion Road Gate entrance, turn left onto Ogden Dr. (first road on the left) and follow until you see a sign on the left.

Foxhound Pool - 186 Foxhound Dr. - 706-640-4037

Foxhound Pool is our smallest outdoor pool and is open from Memorial Day through Labor Day, Thursday-Monday 11:00AM-7:00PM

Tuesday & Wednesday CLOSED

Directions: From the Ellington Road Gate, go straight at the five-way stop and take the first right onto Foxhound Dr. Continue until the road dead ends into Foxhound Pool and the mailboxes.

Tennis Courts at Beaver Lake - 79 Riverview Ct.

Courts are available on a first come, first served basis. No reservation is required.

Same hours as the Recreation Center

Directions: From the Main gate, turn right onto Summit St. (across from Beaver Lake Pond), then turn left onto Riverview Dr. and the tennis courts are on the left.

Directions to Campgrounds, Parks, and Pavilions

Ogden Road RV Park - 2 36th St.

Directions: From Highway 5, take Legion Road to the 3-way stop and turn left to the Legion Rd. Gate. The road will split and come back together, after the speed bump turn left onto Ogden Dr. Go 1.5 miles, then turn right onto 36th St.

East Park - 449 Cherokee Trl.

Directions: From Ellington Rd. Gate (off Hwy 5 at Georgia Forestry sign), after you enter the gate, turn right at the five-way stop onto Spindrift Ct. and follow that until the road dead-ends into East Park.

Fish Trap Park - 491 Zeblin Rd.

Directions: From Ellington Road Gate (off Hwy 5 at Georgia Forestry sign) after you enter the gate, go straight at the five-way stop and continue on Riverview Dr. Turn right onto Zenith Trl, then turn left onto Zeblin Rd. and continue until it dead-ends into the park.

North Park - 208 Edgewater Dr.

Directions: From Ellington Rd. Gate (off Hwy 5 at Georgia Forestry sign) after you enter the gate continue straight at the five-way stop onto Riverview Dr., then turn left onto Edgewater Dr. and continue to the park.

River Park – 1350 Beaver Lake Dr.

Directions: From Main Gate entrance off Hwy 382, continue on Beaver Lake Dr approx. one mile, go past Beaver Lake Pond to the river to River Park.

Canoe Park - 3919 Newport Rd.

Directions: From the Main Gate entrance off of Hwy 382, follow Beaver Lake Drive to Villa Drive to Indigo Dr. to Lemmon Ln. to Jersey Fleur Dr. to Newport Dr. to Fife Bridge. Canoe Park is on the right before the bridge.

Directions to the Water Tower Conference Center and The Fireplace Room

Water Tower Conference Center – 135 Water Tower Villa Circle

Directions: From the Main Gate entrance off of Hwy 382 on Beaver Lake Dr., go approx. ½ mile and turn left on Creekside Trail. The road name will change, but keep straight on the paved road 1½ miles to the Water Tower at the top of the hill.

The Fireplace Room – 634 Beaver Lake Dr.

Directions: From the Main Gate entrance off of Hwy 382 on Beaver Lake Dr., go ½ mile and turn right into the POA at the mailboxes.



Community Access

Assessments

Assessments are due annually on May 1st. Late fees and interest are charged after May 31st.



TAMPERING POLICY

Coosawattee River Resort Association Eagle Mountain Campground Water System will prosecute any individual or company engaged in unauthorized tampering.

Tampering means the unauthorized interface with the equipment, monitoring devices, treatment devices, fire hydrants, valves, and any other appurtenances used to provide water service.

This shall include the theft of water by any unauthorized manner, including through metering devices or bypassing such a device.

The theft shall be reported to the law enforcement in the jurisdiction of occurrence. For each event, the fee shall be \$1,000.00 with the possibility of criminal charges filed.
